WHAT KIND OF PRODUCT IS IT?

Type	It is a matched open-ended investment fund investing in bonds in the developing world.
Term	The Fund was set up for an unlimited period. However, it can be terminated at any time if effective management is no longer possible or if changes in economic and/or political conditions require its liquidation.
Objectives	<p>The objective of the Subfund is to provide balanced asset growth. At least 80% of the Subfund’s assets are invested in the most promising government, municipal, and corporate debt securities in the developing world, selected by the manager. The Subfund combines riskier (corporate bonds) and safer (government and municipal bonds) investments to ensure a balanced return on investment. The Subfund’s assets are invested in developing regions of the world, but the investments are not limited to industry or other market sectors or specific asset classes.</p> <p>If the market situation does not offer better investment opportunities, up to 100% of the Subfund’s assets may be invested in deposits, money market instruments and units, and shares of matched collective investment undertakings whose principal investment focus is money market instruments or bonds and other forms of non-equity securities. The Subfund’s assets may be invested in derivatives if they are used to manage risk. Subfund benchmark: 0.5 * JP Morgan Emerging Markets Bond Index Global Hedged EUR (J.P. The management company can choose specific investments at its own discretion. The risk indicator assumes that the product will be kept for 2 years.

The summary risk indicator shows the risk level of this product compared to other products. It shows how likely it is that the product will result in a loss, either because of changes in markets or because we cannot pay you.

We have assigned this product to risk class 4 out of 7, with 4 being medium risk. This means that losses related to future performance are likely to be moderate.

The following are the types of risks that the Fund may encounter and are underestimated in the calculation of the indicator:

Credit risk. The risk of loss due to the inability of the issuer of the securities to meet its financial obligations.

Counterparty risk. The risk that the counterparty will default on its obligations.

Market liquidity risk. Risk of losses due to low market liquidity, which prevents financial instruments from being sold at the right time at the right price.

Operational risk. Risk of loss due to system failure, human error or external events, including geopolitical, political and legal risks.

The purpose of derivatives is to hedge against adverse market movements for a limited period of time and to reduce the impact of undesirable risk factors

PERFORMANCE SCENARIOS

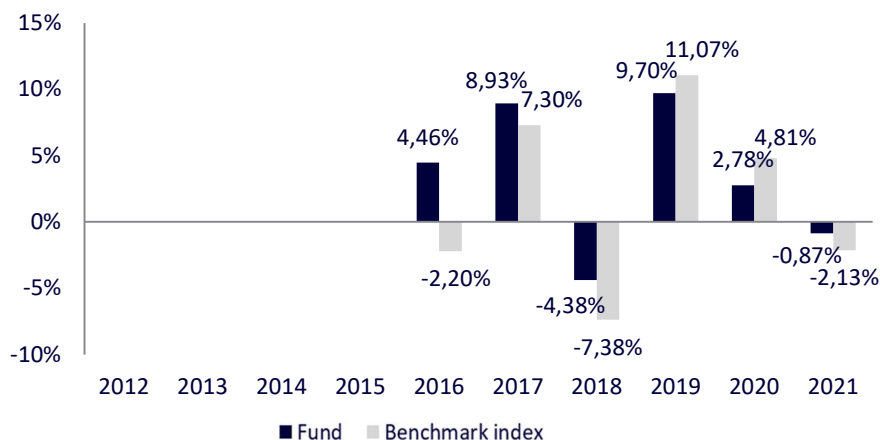
